1. Under no circumstance will this dog/puppy be re-sold, leased or given away to any pet shop or laboratory or similar facility. _____
 2. New owner(s) agrees to have the purchased or adopted pet seen by a licensed veterinarian within 3 days of its delivery. _____
 3. This pet will be housed indoors and it will not be allowed to roam outdoors even if you have an enclosed back yard fenced. _____
 4. The New Pet Owner(s) _____ agree(s) to spay/neuter within two months of acquisition. _____
 5. The New Pet Owner will be responsible for any vet bill once the adoption is finalized (meaning once the pet is delivered or picked up). _____
 6. Your new pet should see a vet within 3 days or earlier after being adopted and delivered/picked-up. It is highly recommended that during these 3 days this pet be isolated from all other animals. _____
- 6. A One-Year Health Guarantee** on this pet regarding any hereditary life threatening congenital disease that is discovered by a licensed veterinarian within one year of its adoption will be remedied by a the replacement of another pet (dog/puppy) of equal value. However, first a written report from the licensed veterinarian as well as a review from our chosen veterinarian must be obtained. Should this pet die within a year of its adoption and the cause was determine to be from any hereditary life-threatening disease, a necropsy report provided by the purchaser's vet must be provided to the seller before a

replacement can be done. There is no health guarantee against treatable problems such as, but not limited to internal/external parasites, etc._____

Failure to have the new pet seen by a vet within 3 days will render this contract breached on the part of the seller and will void the health guarantee

There will not be a refund of the purchase/adoption price, medical cost, or shipment cost under any circumstance. _____

This Health Guarantee does not cover any illness or condition that is not a life threatening congenital defect._____

7. Buyer agrees to accepts the responsibility and provides for the welfare of this pet. The buyer will also provide regular grooming, dental, eye and ear care, flea and tick prevention treatment, de-worming, applicable vaccinations, and heartworm preventative care for this pet._____

*8. Should the New Pet Owner(s) becomes unable to no longer keep this pet, we at FUR OF SUNSHINE will be given first priority in readopting it. Transporting the pet back to us will be at the Pet Owner's expense and the pet must be current on shots with no contagious diseases and be accompanied by a licensed vet issued health certificate._____
